**SALE OR DISPOSAL WITHOUT  
 REGISTRATION CERTIFICATE;  
 NON-REGISTRATION**

**RULE 7: SALE OR DISPOSAL WITHOUT REGISTRATION CERTIFICATE; NON-REGISTRATION**

- A. The recorded owner of any registered horse sold or dispersed without a Registration Certificate, (i.e. “sold without papers”) shall surrender the original Registration Certificate to the Registry for cancellation along with a written statement of the rationale for cancellation. Cancellation will not be accepted if the request is made as a reflection of purchase price or for any other reason deemed by the Registrar to be inappropriate.
- B. After cancellation of the Registration Certificate, it may be renewed, reissued, or reinstated only upon written request of the recorded owner.
- C. A breeder can choose to not register a horse. The breeder may submit to the Registry a letter documenting the breeder’s intention that the horse remain unregistered. The stated intention may later be revoked by a further writing from the breeder.
